## **Article 1. The Erasmus+ Program**

Detailed information regarding student mobility through the ERASMUS+ program is provided by the ERASMUS+ Coordinator of the Department of Midwifery, the Department's website, and the Department of International Academic Affairs and Student Exchange at: https://erasmus.uniwa.gr.

## **Article 2. Mobility for Studies**

Through the Erasmus+ program, postgraduate students have the opportunity to attend part of their curriculum (e.g., specific core or elective courses not offered in their home program) or to carry out part or the entirety of their thesis, master's, or doctoral research in a country of the European Union or other participating countries (Erasmus+ International).

## **Article 3. Basic Eligibility Criteria**

In order to participate in the Erasmus+ program, students of the Inter-Institutional – Interdepartmental MSc "Resuscitation" must:

- 3.1. Be enrolled in the MSc "Resuscitation".
- 3.2. Postgraduate students must be at least in the 1st year of studies and must have successfully registered for the first standard semester.
- 3.3. There must be an inter-institutional agreement between the Department of Midwifery (which administratively oversees the MSc "Resuscitation") and the host institution.
- 3.4. The study period at the host institution must last at least one academic period.
- 3.5. Fulfill the evaluation criteria established by the ERASMUS Committee. Student selection is primarily based on an index derived from the total number of ECTS credits earned divided by the number of semesters attended. In case of a tie, additional factors include overall performance and grades, choice of destination country with low mobility rates, foreign language proficiency, multilingualism, and gender balance.

## **Article 4. Participation Requirements**

- 4.1. Students must be citizens of an EU member state or of another Erasmus+ programparticipating country.
- 4.2. They must be at least in their 1st year of study and have successfully completed at least 50% of the total ECTS credits up to the current semester, while also having at least 60 ECTS remaining before graduation.
- 4.3. Students must have sufficient knowledge of the language in which the courses are delivered at the host university. The required proficiency level can be found on the university website. Exceptions are made for theses, which may be written in English.
- 4.4. Each student may receive a mobility grant for up to 12 months per study cycle, regardless of the type (studies or traineeship). No tuition, registration, or examination fees are charged by the host institution, while national scholarships and student loans remain in effect.

#### **Article 5. Student Selection Criteria**

Students are selected by the MSc Program Committee based on their university preferences and the Erasmus+ selection regulations. Evaluation includes:

- Academic performance (degree GPA)
- Ratio: ECTS successfully earned / ECTS required according to curriculum
- Year of study (including previous mobility periods)

Additional selection criteria based on the Department of Biomedical Sciences' decision:

- Language proficiency level (5 points for A1 up to 30 points for C2)
- Motivation letter for studying at a specific university (up to 10 points)
- Knowledge of an additional foreign language (5 points)

A ranked list per host university is created, considering:

- Language of instruction and the required level of proficiency
- Motivation and justification for Erasmus+ study in the specific university

## Ranking priorities by study level:

- 1. Doctoral candidates
- 2. Postgraduate students
- 3. Senior undergraduate students

Tiebreaker criteria: academic performance, destination with low mobility, language

proficiency, multilingualism, and gender balance.

#### **Article 6. Announcement of Results**

Selection results are posted on the MSc program's website within a reasonable time after the application deadline.

## **Article 7. Course Recognition – Before Departure**

Erasmus+ ensures full academic recognition of studies abroad. Participation implies automatic recognition of the courses included in the *Learning Agreement for Studies* and any changes (*Changes to Learning Agreement*).

The Learning Agreement must be approved by the ERASMUS+ Coordinator of the MSc Program. Courses not listed or not successfully completed at the host university will not be recognized.

Course equivalence is determined by the MSc Coordination Committee upon recommendation by the Erasmus+ Coordinator. Non-equivalent courses are listed in the Diploma Supplement.

Mobility of one semester must correspond to up to 30 ECTS credits.

## **Article 8. Course Recognition – Upon Return**

Upon return, the student must provide official documentation from the host university listing:

- Course titles
- · Grades received
- Number of ECTS
- Grading scale

Grades must be recorded for all selected courses (Pass/Fail) in the *Transcript of Records*. The "Section to be completed after the mobility" in the Learning Agreement must be filled out.

Start and end dates of mobility must be certified in the *Certificate of Attendance*.

The final language proficiency assessment is mandatory.

## **Article 9. Funding**

Students receive a grant amount based on their destination country.

A maximum of 12 months of Erasmus+ mobility per study cycle is permitted.

Students may go on study mobility only once per study cycle (3 to 12 months).

Initially, 80% of the grant is paid, with the remaining 20% given upon return, subject to the following conditions:

For 2nd and 3rd cycle postgraduate students, a passing grade or positive evaluation in their practical training is required.

## **Article 10. Extension of Mobility**

Mobility can be extended up to the 12-month maximum.

Requests must be submitted at least one month before the current mobility ends, including:

- Email request to the Erasmus Office
- Written approval from the host institution
- Completion of the "Section to be completed during the mobility" in the Learning
   Agreement

## **Article 11. Publication of the Regulation**

This mobility regulation is published on the official website of the MSc "Resuscitation".
